Because of the rising adoption of medical and aesthetic laser technologies, there will be significant increase in the demand for the devices like dermatology lasers. Among which, the countries – US and Brazil are the key countries that has more demand for these [dermatology](#) devices.

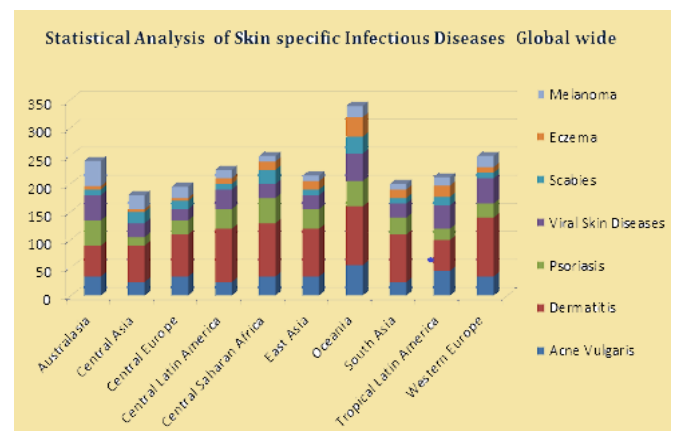
The dermatology lasers market will grow at CAGR (Compound Annual Growth Rate) of over 15% in the Americas by the year 2023. Also, in Asia-Pacific countries, the demand for these lasers is high.

In Asian countries, the adoption of anti-aging treatments is increasing. Apart from this, countries like France, Germany and Italy are having the major markets for dermatology devices. The global [dermatological](#) drugs market was 10.37% in the year 2018.

### Dermatology Drugs Market Competitive Landscape:

Regulatory authorities like U.S. Food and Drug Administration (USFDA) and the European Union (EU) have approved various dermatological drugs manufactured by key players. This is positively affecting the growth of the dermatology drugs market.

For example – Priority review for Sanofi’s supplemental Biologics License Application (sBLA) for Dupixent (dupilumab) as potential treatment for adolescent patients (aged 12–17 years) with uncontrolled moderate-to-severe atopic dermatitis has been granted by USFDA in November 2018.
