We are pleased to mention that during the year 2020, all issues of volume 6 were published online successfully within the time and the print issues were also brought out and dispatched within 30 days of publishing the issue online. All published articles of this journal are included in the indexing and abstracting coverage of Google Scholar, Genamics Journal Seek, China National Knowledge Infrastructure (CNKI), CiteFactor, Directory of Research Journal Indexing (DRJI), IndianScience.in, Jour Informatics, CiteSeerx, American Standards for Journals and Research (ASJR), InfoBase Index, Secret Search Engine Labs During the calendar year 2019, IPAPP received a total of 20 papers, out of which few articles wererejected in the preliminary screening due to plagiarism or being out of the format and peerreview process.

During 2020 around 10 articles were subjected for publication after they areaccepted in the peer review process. In the 1 issues of Volume 8 published during the year 2020, a total of 10 articles were published (at an average of 5 articles per issue) of which, articles were published from authors all around the world. A total of 58 research scientists from all over the world reviewed the 13 articles published in volume 8. Average publication lag time of an article was further reduced to 2-3 weeks.
