



Joubert Syndrome: The Past And Current, Single Social Experience ; Case Study

Abstract:

Joubert syndromes are a recessive autosomal disease, characterised by a varied mixture of mental retardation, brain ataxia, episodic hyperpnea, disturbances in eye coordination, pervasive hypotonia and the visible molar dental signal on the brain image. Since the late French neurologist Marie Joubert mentions the condition in 1969, the number of recorded cases has risen worldwide, but the disease remains underdiagnosed; the major culprits remain the lack of knowledge of its central features and the inexperience in brain imaging. Three Iraqi children diagnosed with Joubert syndrome were documented in 2011 and the first ever Iraqi case series was published. Two were historically misdiagnosed as ataxic brain paralysis and genetic spinocerebellar ataxia. The third boy had missed goals. We have been treating these children consistently every 6 months in ambulatory surgery for the past 2 years. Epilepsy of the first child was well-controlled, and seizures were not documented while the diffuse ictus of the second child was more or less similar, with a mild learning disability and cerebellar ataxia. The congenital amaurosis of Leber the third child and his impaired vision have not improved and he can not rise or rise without much help; he is 2 years old and 7 months pregnant. Neither child has the same disease family history. During the past 2 years of follow-up, no renal or hepatic effects were found.
